Dear Sir,

Kindly refer to Member(Admn)'s D.O. letter of even number dated 08.08.2017 (copy enclosed) and subsequent communications regarding implementation of recommendations of 7th CPC - Revision of Pension of pre-2016 pensioners/ family pensioners.

2. It has been noted that despite repeated communications from Member (Admn), many Zones/ Directorates have not completed the task of pension revision by the prescribed date i.e. 01.03.2018. nor the extended date i.e. 31.03.2018.
