Dear Sir,

Please refer to Member (Admn)'s D.O. letter of even no. dated 09.10.2017 and subsequent letters dated 26.10.2017, 20.11.2017 and 12.12.2017 regarding implementation of recommendations of 7th CPC for revision of pension of pre-2016 pensioners/family pensioners.

2. During the review meeting held by Addl. Secretary (Expenditure) to review the progress of revision of pension of pre-2016 pensioners/family pensioners, it has been directed that the pending cases of revision of pension of pre-2016 pensioners/family pensioners must be finalized by 28.02.2018.
3. Further, as per the information received from field formations, the number of cases requiring revision of pension is **35,743**, out of which pension has been revised in respect of **28,403** cases and **7,340** cases are still pending. However, as per the PAO-wise status report received from Pr. CCA, CBEC (copy enclosed for ready reference) the number of cases requiring revision of pension is **41,071**, out of which pension has been revised in respect of **27,945** cases and **13,126** cases are still pending.
4. It is requested that the concerned HOOs/DDOs may be directed to reconcile the figures in consultation with the concerned PAOs and complete the work of revision of pension of pre-2016 pensioners before 28.02.2018 positively.
