

Minutes of the meeting held on 04.08.2017 under the Chairmanship of Addl. Secretary (Expenditure) to review the preparedness for implementation of revision of pension of pre 2016 pensioners/family pensioners.

List of participants is enclosed.

2. Welcoming the participants to the meeting, the Chairman invited their attention to the deliberations held during the first review meeting held in this regard on 22.6.17 wherein it was taken note that the issue had not received due attention and the pace of work was rather slow. While emphasizing the need for expeditious settlement of live pension cases, effective monitoring of the progress at higher level was also stressed upon.
3. It was brought out by the Chairman that in order to have meaningful discussion in the next review meeting, the participants were also requested vide O.M. dated 26.7.17 of this Department to be ready with certain basic information and they were also requested to bring out any relevant issue having a bearing on speedy disposal of revision of pension cases.
4. Attention of the participants were also drawn to Finance Secretary's D.O. letter dated 27.7.17, addressed to the Secretaries of all Ministries/Department, wherein it was suggested that clear timelines to complete the revision exercise be drawn.
5. The participants were requested to give the status on the action taken by them to revise the pension of pre-2016 pensioners. It was, however, noted that the participants were neither prepared with the desired information nor they had given any thought to the information sought in the O.M. dated 26.7.17. Further, it was felt that the progress of pension revision was still tardy and that there was no effective monitoring mechanism put in place.
6. The Chairman observed that in such circumstances, the meeting to review the progress of pension revision won't serve any purpose. The participants were again advised that this work should be given priority, clear timeline be drawn to complete the exercise in a time bound manner and the progress be monitored periodically at the level of Jt. Secretary (Admn).
7. Some of the participants mentioned that it was taking time to collect Aadhaar number as this is required to be filled up in the form devised by CPAO. The representative of CPAO clarified that this field is not mandatory. The Chairman directed that necessary clarification in this regard may be issued immediately by CPAO.
8. The Chairman directed that the work relating to revision of pension must be given due attention. All the participants were requested to come prepared with the information sought for vide O.M. dated 26.7.17 before the next review meeting which will be held shortly.

The meeting ended with a vote of thanks to the Chair.
