Office Order No. 60/2016

In pursuance of Government of India instructions issued from time to time on the need for periodical review of performance of Government servants in terms of FR 56(j), FR 56(l) and Rule 48(1)(b) of CCS Pension Rules, 1972, cases of Government servants should be reviewed six months before he/she attains the age of 50/55 years in cases covered by FR 56(j) and on completion of 30 years of qualifying service under FR 56(l)/Rule 48 of CCS(Pension) Rules, 1972.

2. In pursuance of the instructions issued by Department of Personnel and Training (DOP&T) vide OM No 25013/01/2013-Estt A-IV dated 11.09.2015 and 01.03.2016, it has been decided with the approval of the Competent Authority to constitute Representation Committees in respect of officers holding Group 'A', 'B', 'C' and 'D' (erstwhile) posts in the CBEC with the following composition:-

(A) For ACC / Non ACC appointee IRS(C&CE) Group A Officers:

- (i) Shri B.P. Sharma, Secretary, D/o Health & Family Welfare
- (ii) Ms. Deepti Umashankar, Joint Secretary, Cabinet Secretariat

- Commissioner (Logistics) for the posts of Telecommunication Wing & Marine Wing and Post of Director, CRCL;
- DG Systems for the posts of Directorate of Data Management;
- Director (RL) for all Gr.'A' post of CRCL other than Director (RL);
- Chief Controller of Accounts, CBEC for all the posts of CAO (Chief Accounts Officer)



(C) Group 'B', 'C' & 'D' (erstwhile) officers under CBEC:

The concerned Chief Commissioner/Director General of Customs and Central Excise will be associated for presentation of the cases, alongwith relevant records, of the officers pertaining to their Commissionerate/Directorate before the Representation Committee.

6. All the Cadre Controlling Authorities are requested to assist the above Committees in disposal of representation of the officers, who have been retired under FR 56(j), FR 56(l) and Rule 48(1)(b) of CCS Pension Rules, 1972, in terms of the instructions laid down by DoP&T.
