Dear *Colleagues,*

Kindly refer to Board's letter of even no. dated 26<sup>th</sup> May, 2017, and subsequent communications dated 01.06.2017, 14.06.2017, 04.07.2017, 19.07.2017, 25.07.2017, 01.08.2017 and 04.08.2017 regarding implementation of the Seventh Central Pay Commission - Revision of Pension of pre-2016 pensioners/family pensioners.

2. In this connection, I am constrained to say that the progress made in revision of pension is very slow and very few offices have sent their reports. It is needless to point out that the work relating to revision of pension is required to given top priority and completed in a time bound manner. The progress of revision of pension is being monitored by Department of Expenditure.

3. I would, therefore, like to impress upon you to ensure timely revision of pension of pre-2016 pensioners/family pensioners and send fortnightly report to this office indicating -

- (i) Total number of pre-2016 pensioners/family pensioner (scale wise) requiring revision,
- (ii) No. of cases where revised PPOs have been issued (scale-wise) and payment of revised pension and arrears made,
- (iii) Percentage of cases yet to be revised w.r.t. (i); and
- (iv) Specific reasons for delay.

4. You may also intimate whether the pension revision has been taken up scale-wise and whether revision in regard to fixed pay scales has been completed. Your report for the first fortnight of August, 2017 may be sent to Commissioner (Coord) by **18.08.2017** positively by e-mail at [hema.priya@nic.in](mailto:hema.priya@nic.in).
