Shri Sandeep Bhattacharya, IRS (C&CE: 1993) (Emp Id No. 795, D.o.B. 03.02.1968), Additional Commissioner, is absconding from duty unauthorizedly since 01.08.2005, Inspite of repeated attempts to make contact with him, including putting up a public notice in the Dainik Jagran (Hindi) and the Hindustan Times (English) on 10.06.2017, there has been no response from him.

2. Now, therefore, in terms of DoP&T's Notification [G.S.R. 261 (E)] dated 29.03.2012 read with Rule 12 (2) of CCS (Leave) Rules, 1972, which states that "a Government servant who remains absent from duty for a continuous period exceeding five years other than on foreign service, with or without leave, shall be deemed to have resigned from the Government Service; provided that a reasonable opportunity to explain the reasons for such absence shall be given to that Government servant before provisions of sub-rule (2) of CCS (Leave) Rules, 1972 are invoked", the President is pleased to treat Shri Sandeep Bhattacharya as deemed resigned from Indian Revenue Service (Customs and Central Excise) with effect from 01.08.2005.

3. Shri Sandeep Bhattacharya shall not be entitled for any retirement benefits.
