Subject : Preparation of panel for appointment of officers on **deputation basis** in the grade of **Inspector**, in the Directorate General of Vigilance, Ahmedabad Zonal Unit, Ahmedabad - regarding.

Directorate General of Vigilance, Ahmedabad Zonal Unit is in the process of drawing a panel of willing and suitable candidates for filing up of **05 (Five) posts of Inspectors**, on deputation basis.

2. It is proposed to fill up these vacancies by appointing suitable officers from the grade of Inspector of Central Tax & Customs **on deputation basis**, with minimum three years of service in the grade.
3. Normally, the posting on deputation basis is for a period of three years, which may further be extended for a period of one year, subject to willingness of the officer, his/ her performance, concurrence of his parent Commissionerate and approval of the competent authority.
4. It is requested that this Circular may please be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office latest by **29.06.2018**.
5. While forwarding the names of the willing officers, the following information in respect of them may be furnished for evaluation by this Directorate.

- (a) Complete Bio-data and willingness letter of the officer along with history of previous postings;
- (b) ACR/ APAR gradings for upto last (5) Five years, duly verified and attested by the Additional/ Joint Commissioner (P&V);
- (c) Vigilance Clearance Certificate; and
- (d) **No objection Certificate from the Cadre Controlling Authority** to relieve the officer in the event of his/ her selection.

6. This letter may kindly be widely circulated among all the offices/ field formations in your jurisdiction.
