Subject: Preparation of panel for deputation in cadre of Intelligence Officer in the Directorate of Revenue Intelligence, Lucknow Zonal Unit, in Pay Band-2 of Rs.9300-34800/- + Grade Pay 4600/- or above (Pre-revised 7th CPC) - reg.

The Directorate Revenue Intelligence, Lucknow Zonal Unit is in the process of drawing a panel of suitable candidates for filling up vacancies in the grade of Intelligence Officer (I.O.) on deputation, in the (Pre-revised) Pay Band -2 of Rs. 9300-34800/- + Grade Pay of Rs.4600/- or above, as mentioned below:-

2. These posts will be filled up on deputation basis from amongst the officers of the similar ranks working in the formation of Customs, Central Excise and Service Tax and officers holding analogous posts in the Directorate General / Directorates under CBEC in the same pay scale.

- 3. The selected officers, on appointment, will be entitled for Deputation allowance as per relevant orders after implementation of VIIth Central Pay Commission and they have to make their own arrangements for residential accommodation. Normally, the deputation in respect of SIO/IOs are for a period of five years, which is extendable by another two years subject to willingness of the officers, his/her performance, concurrency of his/her parent Commissionerate and approval of the Competent Authority.
- 4. It is requested that the Circular may be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office within 30 days from the issue of the circular. While forwarding the names of the willing officers, the following information may also be sent for evaluation by this Directorate:
 - I. Complete Bio-data and willingness letter of the officer along with History of Previous Postings;
- II. APAR/ACR Gradings for the last 5 years duly verified and attested by the Additional/Joint Commissioner (P&V);
- III. Vigilance Clearance Certificate; and
- IV. No objection from Cadre Controlling Authority to relieve the officer in the event of his/her selection and permission to relax the 'Cooling off' period wherever applicable.
- 5. In case, while working in this Directorate, the work and conduct of the officer is not found to be satisfactory, the officer can be reverted to the parent Commissionerate / Directorate before completion of the deputation period.
- 6. The above mentioned information / details may kindly be furnished at the earliest.
