Subject: Preparation of panel for appointment of officers on deputation / loan basis in the Cadre of Senior Intelligence Officer & Intelligence Officer in the Directorate General of Revenue Intelligence, Ludhiana Zonal Unit, and its Regional Units at Amritsar/Jammu and Srinagar- regarding.

Directorate General of Revenue Intelligence, Ludhiana Zonal Unit is in the process of drawing up a panel of willing and suitable officers for filling up the posts of Senior Intelligence Officer & Intelligence Officer in the Directorate General of Revenue Intelligence, Ludhiana Zonal Unit, and its Regional Units at Amritsar/Jammu and Srinagar on deputation/loan basis. The existing vacancies in the grade of S.I.O. & I.O. are enumerated as below:

For Senior Intelligence Officer:

2. It is proposed to fill up these vacancies by appointing suitable officers from respective grades of officers of Central Tax & Customs on deputation/loan basis. For filling the post on deputation basis officers with minimum three years of service in respective grade and for loan basis officers with minimum experience of two years may apply.

3. Normally, the posting on deputation basis is for a period of five years, which may further be extended for two years one at a time, subject to willingness of the officer, his/her performance, concurrence of his parent Commissionerate and approval of the competent authority. For loan basis tenure is for two years, which may further be extended for subject to willingness of the officer, his/her performance, concurrence of his parent Commissionerate.

4. During the period of posting on loan basis, the pay and other allowances of the concerned officer(s) shall be drawn from their respective parent Commissionerate(s).

5. It is requested that this Circular may please be brought to the notice of all the formations under your jurisdiction and the application of willing officers be forwarded to this office. While forwarding the names of the willing officers, the following information in respect of them may be furnished for evaluation by this Directorate.

- i. Complete Bio-data and willingness letter of the officer alongwith history of previous postings;
- ii. ACR / APAR gradings for upto last (5) five years duly verified and attested by the Additional / Joint Commissioner (P&V);
- iii) Vigilance Clearance Certificate; and
- iv) No Objection Certificate from the Cadre Controlling Authority to relieve the Officer in the event of his / her selection.

6. The above information may please be furnished to this office of Directorate General of Revenue Intelligence at the earliest.
