**1. Administrative Changes:-**

- Order regarding temporary attachment of 02 IRS(C&CE) with Directorate of International Customs, has been issued vide Office Order No. 45/2019 dated 08.04.2019.
- Order regarding appointment of Shri S.M. Tata, IRS (C&CE) officer as OSD in CBIC, has been issued vide Office Order No. 46/2019 dated 09.04.2019.

- Notification No. 16/2019-Cus (ADD), dated 09.04.2019 has been issued to rescind Notification No. 21/2015-Customs (ADD), dated 22.05.2015.
- Notification No. 17/2019-Cus (ADD), dated 09.04.2019 has been issued to impose definitive anti-dumping duty on Cast Aluminium Alloy Wheels or Alloy Road Wheels used in Motor Vehicles originating in, or exported from China PR till 09.05.2019.
- Notification No. 13/2019-Cus, dated 11.04.2019 has been issued to amend Notification No. 39/96-Customs dated 23.07.1996 so as to extend the exemption provided to the Light Combat Aircraft Programme of the Ministry of Defence till 31.06.2019.
