1. Administrative Changes:-

- Order regarding posting of Shri Jitendra Kumar, IRS(C&CE: 1996), Commissioner, Varanasi GST & CX, as OSD (Review) in CBIC on loan basis, has been issued vide Office Order No. 20/2019 dated 13.02.2019.
- Order regarding posting of Shri Kevin Boban, IRS(C&CE: 2014) Deputy Commissioner, Panchkula, as OSD (Customs) in CBIC on loan basis, has been issued vide Office Order No. 21/2019 dated 14.02.2019.
- In compliance of CAT, Guwahati Bench order, order regarding retention of two IRS (C&CE) officers at their place of posting i.e. Guwahati GST & CX, has been issued vide Office Order No. 22/2019 dated 14.02.2019.

- Notification No. 11/2019-Cus (ADD) dated 12.02.2019 has been issued to rescind Notification No. 11/2019-Customs (ADD) dated 16.05.2013, which imposed anti-dumping duty on the import of Peroxosulphate, originating in or exported from People's Republic of China.
- Notification No. 10/2019-Cus (ADD) dated 12.02.2019 has been issued to amend Notification No. 35/2018-Customs (ADD) dated 09.07.2018 to amend the name of exporters at S.Nos. 1 and 2 of the duty table.

- Notification No. 09/2019-Cus (ADD) dated 12.02.2019 has been issued to amend Notification No. 52/2017-Customs (ADD) dated 24.10.2017.
- Notification No. 08/2019-Cus (ADD) dated 12.02.2019 has been issued to amend Notification No. 61/2015-Customs (ADD) dated 11.12.2015.
