- Order regarding antedating of grant of Non-Functional Selection Grade in respect of Shri Sabu Jeseeph, ADC(Retd.) has been issued vide Order No. 119/2017 dated 17.07.2017.
- Order regarding assigning of additional charge of the post of DG(Audit), Delhi to Ms. Ameeta ASuri, Member(CBEC) and post of CC,GST & CX, Kolkata to Shri Bijay Kumar, Principal Commissioner has been issued vide Office Order No. 120/2017 dated 17.07.2017.
- Order regarding transfer/postings of 11 officers in the grades of ADC/JC & DC/AC has been issued vide Office Order No. 121/2017 dated 18.07.2017.
- Order regarding allocation of charge among Members of CBEC has been issued vide Office Order No. 122/2017 dated 19.07.2017.

- Notification No. 22/2017-CENT dated 18.07.2017 has been issued to rescind 5 Central Excise (N.T.) notifications.
- Notification No. 03/2017-Compensation Cess(Rate), dated 18.07.2017 has been issued to amend Notification No. 1/2017-Compensation Cess(Rate), dated 28.06.2017 so as to increase the Compensation Cess rates on cigarettes as mentioned in the notification with effect from 18.07.2017.
- Notification No. 04/2017-Compensation Cess(Rate), dated 20.07.2017 has been issued to exempts intra-State supplies of second hand goods received by a registered person, dealing in buying and selling of second hand goods and who pays the goods and services tax compensation cess on the value of outward supply of such second hand goods, as determined under sub-rule (5) of rule 32 of the Central Goods and Service Tax Rules, 2017 from any supplier, who is not registered, from the whole of the goods and service tax compensation cess leviable thereon under section 8 of Goods and Service

Tax(Compensation to States) Act, read with sub-section (4) of Section 9 of the Central Goods and Service Tax Act
