All aspiring advocates who have been in practice as an advocate for not less than 10 years & also qualify in terms of Section 24(8) of the Criminal Procedure Code, 1973 to the Bar Council of Patna High Court or Bar Association of Subordinate Court of Gopalganj and who are desirous to handle the CBEC cases on behalf of the Department may submit their application alongwith Bio-Data in proforma "A" to the Legal Section, Office of the Commissioner of Customs(P), 5th Floor, Central Revenue Building, Birchand Patel Path, Patna-800001" by **04.10.2017**. The first engagement of an SPP shall normally be for a period of 18 months. Such engagement will be renewable on receipt of recommendation of the concerned Chief Commissioner alongwith the annual performance appraisal on completion of first 12 months of the engagement.
